The undersigned, being a parent/legal guardian of the below-named Junior member ("Junior") of Broomstones Curling Club, hereby agrees that I will follow and be responsible for educating said Junior about, and ensuring that said Junior follows, the following club policies during the 2021-22 season:

- If the Junior is a *vaccine-eligible* Broomstones junior member, the Junior must be *fully vaccinated* to enter the building. The Junior is fully vaccinated if the Junior has received 2 doses of either the Moderna or Pfizer COVID-19 vaccines or a single dose of the Janssen (Johnson & Johnson) vaccine more than 14 days ago. I, on behalf of the Junior, will provide proof of the Junior's vaccination as part of the registration process for all curling activities (e.g., practice, leagues, and events).
 - If I wish for the Junior to be *medically* exempted from the vaccination requirement, I will submit a request for exemption and a note from a qualified healthcare provider in writing to medical@broomstones.com for review and approval prior to the Junior's participation in any club activities, including events.
 - If the Junior is an *eligible* but *unvaccinated* member, the Junior will NOT enter the building until the Junior's exemption is approved by the Broomstones medical expert. After the Junior is approved to enter, the Junior will *wear a mask at all times* while in the club and/or curling.
- If the Junior *cannot* yet be vaccinated *due to ineligibility*, the Junior will **wear a mask at all times** while in the club and/or curling.
- I and any guest(s) accompanying me or the Junior to the club (e.g., a non-member parent or older sibling) must be fully vaccinated and over the age of 12 years.
 - Such accompanying person(s) *must*:
 - provide proof of vaccination status; AND
 - upon arrival at the club: sign the <u>non-member</u> attestation form and provide contact info (for contact informing).

I, on behalf of myself and the Junior, am responsible for ensuring that the above procedure and all other club rules are followed by any guest(s).

- If I or the Junior bring(s) a guest (e.g., younger sibling) to the club who is NOT vaccine eligible due to age, I will be responsible for their always wearing a mask. [Children under 2 years of age are not required to wear a mask.]
- I and the Junior agree to treat all members and guests at Broomstones with respect regardless of whether or not they are wearing a mask or taking other health precautions. I and the Junior will not make negative comments to or about members or guests taking such precautions.
- I agree, on behalf of myself and the Junior, that the Junior and I will NOT enter the club if:
 - Either of us is sick, especially if I/we have symptoms of COVID-19, such as:
 - cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, diarrhea;
 - I/We have a fever or felt feverish in the past 72 hours;
 - I/We have been or might have been exposed to COVID-19 in the preceding 14 days;

- I/We have had a positive COVID-19 test result in the past 10 days or am/are awaiting the result of a COVID-19 test (other than mandated surveillance testing), regardless of my/our vaccination status or whether I/we have symptoms.
- If I or the Junior become(s) ill while at Broomstones, I and the Junior person will *immediately*:
 - put on a face mask;
 - maintain at least 6 feet (2 m) of distance from others;
 - let the lead instructor or Junior Program Coordinator know; then
 - promptly leave the premises as soon as able (if the Junior needs to wait for a pickup from a parent/guardian, the Junior will wait at least 6 feet (2 m) away from others).
- I and the Junior agree to follow, *at a minimum*, current CDC and MA Health Department guidance and local and state regulations regarding quarantine and isolation for COVID-19 exposure and illness.
- If I or the Junior test positive for COVID-19, I agree to:
 - Report to the Junior Program Coordinator (or medical@broomstones.com) immediately to allow for contact informing.
 - Obtain clearance from a healthcare professional before I or the Junior return to the club.
- At all times while entering, in, or bringing guests into Broomstones Curling Club, I, for myself and the Junior, agree to follow the Broomstones Opening COVID-19 Policies. I, for myself and the Junior, acknowledge and agree that (i) such Broomstones Opening COVID-19 Policies may be stricter than any local, state, CDC, or federal health regulations, rules, laws, and guidance from time to time in effect; (ii) such Broomstones Opening COVID-19 Policies may change at any time and from time to time; and (iii) I will keep myself and the Junior fully apprised of the current status of such Broomstones Opening COVID-19 Policies so that I and the Junior can remain in compliance.
