

BROOMSTONES YOUTH CURLING
ACKNOWLEDGEMENT, AUTHORIZATION, ASSUMPTION OF RISK
AND WAIVER OF LIABILITY

The undersigned, being a parent/legal guardian of the below-named minor prospective youth curler, hereby acknowledge(s) that said minor seeks to participate in a program sponsored by Broomstones, Inc. (“Broomstones”) for youth curlers.

The undersigned specifically assert(s):

1. That the undersigned is/are the party(ies) who is/are legally responsible for said minor and is/are legally empowered to act for and on behalf of said minor.
2. That the said minor will comply with the rules and regulations of Broomstones.
3. That the undersigned is/are aware that the sport of curling, like any athletic participation, requires physical fitness.
4. That said minor possesses such fitness.
5. The undersigned understand(s) that there is risk involved in curling including, without limitation, because of the danger of slipping or falling on the ice surface on which the sport is played.
6. The undersigned understands that participating in any activity with other people increases the risk of contracting or spreading an infectious disease, including, without limitation, coronavirus disease 2019, which could result in injury or death.

The undersigned specifically acknowledge(s) that a risk of injury, disability, or death exists and assume(s) said risk on behalf of said minor with respect to his/her participation in the Broomstones Youth Curling Program. In the event that said minor attends curling and related events (whether held in conjunction with the Broomstones Youth Curling Program, Broomstones generally, or otherwise) at (i) Broomstones, (ii) curling clubs other than Broomstones, or (iii) other venues which are not part of Broomstones facilities, then, in consideration of Broomstones’ participation in or sponsorship of such program or event, or Broomstones’ provision of, or arrangement for, transportation to or temporary accommodation for such event, or other assistance in connection with or resulting from such event, the undersigned (a) agree(s) to defend and hold harmless Broomstones, its officers, directors, employees, agents, chaperones, and their respective successors, assigns, heirs, and beneficiaries (collectively, the “Releasees”) from any claim, action, suit, damages, attorney fees, and court costs involving said minor related to or resulting from such event and (b) grant(s) to the Releasees a waiver of liability as regards any injury, disability, or death which should occur to said minor arising out of or resulting from his/her participation in such event including, without limitation, as a consequence of, or related to, contracting or spreading any infectious disease, including, without limitation, coronavirus disease 2019. This waiver applies whether or not any Releasee does or does not apply or enforce, attempts but fails for any reason to apply or enforce, or is negligent in applying or enforcing, any steps, policies, programs, directives, orders, or similar efforts to contain or prevent the spread, or reduce the risk of spreading, any infectious disease.
